CONTRACT

INTERNAL APPEAL PROCESS

Following the adjudication of bids and selection of a preferred bidder, and provided that a procurement contract has not already entered into force, any bidder may submit a complaint in writing to the chairperson of the PIKITUP Board of Directors (“the Board”) or the Managing Director that PIKITUP has not complied with the requirements of the PIKITUP Supply Chain Management Policy or the PIKITUP Code of Ethics, or has in any respect acted in a way that is irregular. The Chairperson of the Board or Managing Director shall not entertain a complaint unless it was submitted within 20 calendar days of when the supplier or contractor submitting it became aware of the circumstances giving rise to the complaint or of when that supplier or contractor should have become aware of those circumstances, whichever is earlier; or entertain a complaint after the procurement contract has entered into force.

Unless the complaint is resolved by mutual agreement of the bidder and the Chairperson of the Board or Managing Director, the Chairperson of the Board shall, within 30 calendar days after the submission of the complaint, issue a written decision. The decision shall state the reasons for the decision; and if the complaint is upheld in whole or in part, indicate the corrective measures that are to be taken.

The decision of the Chair of the Board shall, subject to the review powers of any competent court, be final.

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.

9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

Specifications for the requisition of Landfill site survey

1. BACKGROUND

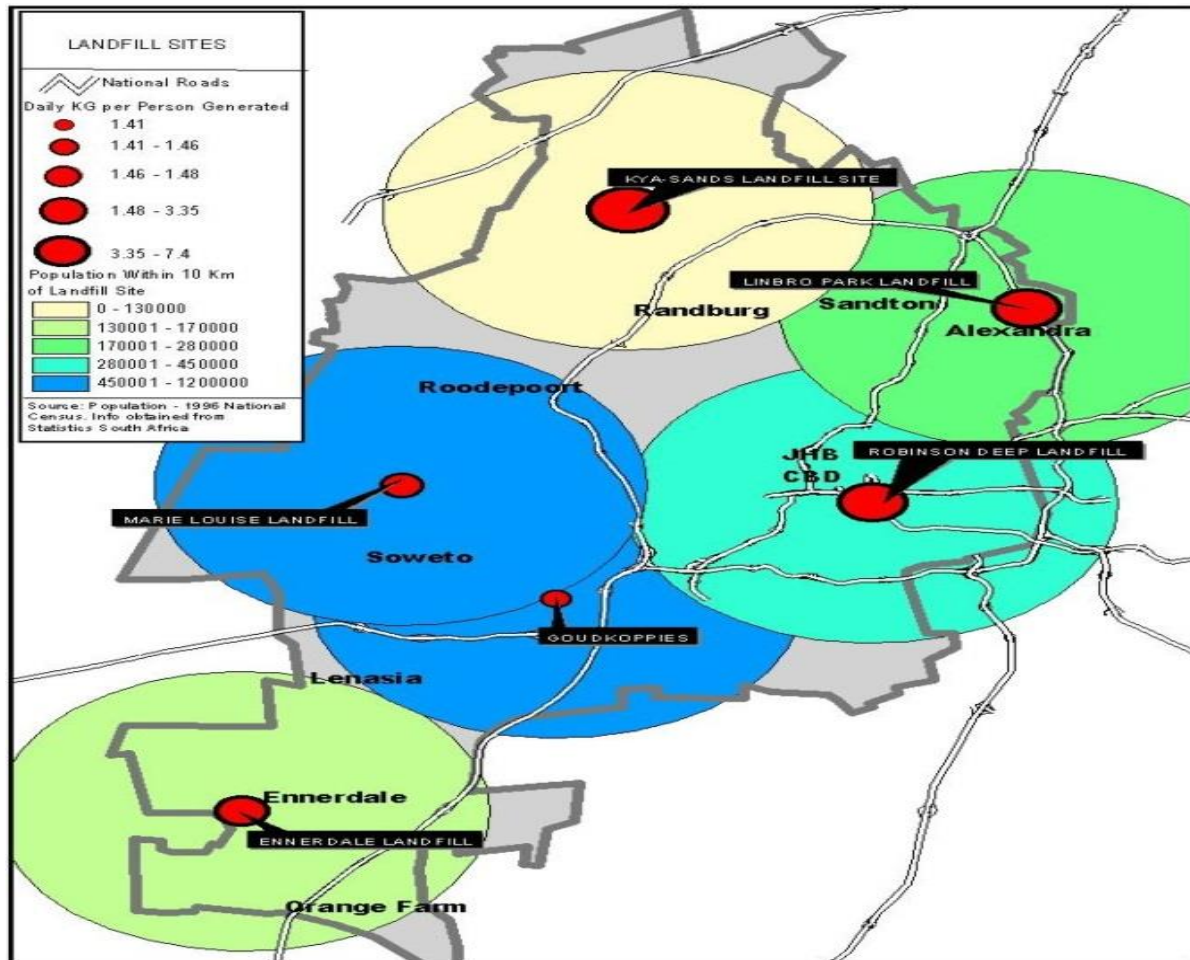
The purpose of this specification is to appoint a service provider to undertake **topographical surveys**, at the four of Pikitup's operating landfills. The service provider would also be required to report on **monthly airspace consumption** and **depletion** as well as conducting **compaction density** at all operating landfills. The following are the sites to be surveyed:

- Robinson Deep, approximately 124 ha;
- Marie Louise, approximately 57 ha;
- Goudkoppies, approximately 41.2 ha; and
- Ennerdale, approximately 21 ha.

Figure 1 on the next page 27 depicts the position of the landfill sites in question within the Greater Johannesburg Area.

Landfill provision for rehabilitation has a significant impact on the company financial statements and therefore topographical surveys are monthly required to scientifically determine landfill airspace depletion, as well as determining completed areas requiring rehabilitation. The accuracy of the results of these surveys is critical and must be undertaken by a professionally competent and highly experienced volumetric topographical surveyor. It is vital to substantiate landfill rehabilitation requirements to the Auditor General.

2. REQUIREMENTS

Here the surveys are requested at the four operational landfill sites are as follows:

1. Provide air space calculation reports and survey maps for the 4 landfill sites in a form of electronic and two hard copies per landfill site;
2. The Surveyor must have more than 2 years of experience in volumetric surveys;
3. Certified certificates of Qualifications and Registered Professional bodies must accompany the quotations;
4. The survey results must be presented in the form of a survey plan, showing survey results to the licensed boundaries of the landfill site at the time of the survey.
5. The terrain levels must be represented on the survey plan by contours at not more than 1 metre intervals.
6. The spot levels must be taken at sufficient frequency to allow interpolation of levels from the survey plan to ± 0.2 metres at the 90% confidence level.
7. The survey plan must include amongst others the boundaries of the site, date of survey, adjoining title information, scale bar, buildings, roads, fences, ponds, landfill cell extraction areas, weighbridges, settlement, subsidence and any other significant details that will likely impact on the volume usage are noted on the survey plan.
8. The boundaries of all active cells which received waste during the survey period must be noted on the survey plan.

9. All changes in the volume in the active cells and any other area on the facility during the survey period must be noted on the survey plan.
10. The stockpile locations must be clearly noted on the survey plan and provided with an identification number.
